Note:

- The new dedicated social and study space will be approximately 40,000 square feet, which is approximately the same size as the existing library building.
- The new student society fee will be levied on all active UBCSUO members in semester one and two. No fee will be levied in the summer semester.
- The new student society fee will continue to be levied until UBCSUO has raised \$8 million dollars to be used toward the construction of the new social and study space.
- The \$8 million contribution will be prominently acknowledged in the social and study space.
- The total cost of construction is estimated to be \$24 million.
   The remaining \$16 million for the cost of construction will be sourced by UBC.
- The new student society fee will not be levied until UBCSUO and UBC reach agreement on the terms relating to the construction of the new dedicated social and study space, including the location of the space on campus.
