5.9.2.2 BIRT: The Recess budget be adopted to add \$20,000 to the sponsorship amount provided by UBCSUO.

> Azzam to bring in a bigger artist. Azzam felt we had always been on the cusp of attracting a larger artist but they have fallen through last minute or become too popular before we have signed them.

Jain explained the artist budget for Recess has already received \$12,000 more than any previous Recess/Frosh

Alhuwayshil would like to see a motion stating how much the sponsorship is.

Ouellet explained this is already a line item in the budget so the \$55,000 has already been adopted.

Cain from Blueprint stated that selling 4000 tickets may be a challenge but it's all about finding the right artist.

Jain: Our funding model needs to be followed as none of these events have ever come within the provided budget.

Azzam: We are not going in blind, we have done these events before.

Moffat: She is not sold that this model could work.

Azzam agreed and stated the artist would be established.
