- 2. The financial statements of the Student Union shall be published annually, no later than the fifteenth (15th) of November of each year, in a Student Union publication, or any other campus newspaper, and shall be made available at the main office of the Union.
- 3. The Student Union shall not operate at a deficit.
- 4. The following persons shall be the signing officers for the Student Union:
 - a) the Vice-President Finance and Administration; and
 - b) the President;
 - c) the General Manager;
 - d) the Vice-President Services.
- 5. All expenditures must be signed off by at least two signing officers. The Vice-President Finance and Administration or General Manager shall be one of the two signatories. In the event that both the VP Finance and Operations and General Manager are on vacation, leave, or the positions are vacant, the other two signatories shall suffice.
- 6. All signing officers shall be bonded by a fidelity bond which shall indemnify the Student Union to the extent that Board of Directors and the General Manager deem necessary.
- 7. The Board of Directors shall include additional financial controls and procedures in the Regulations.
